Grand Opening of Oaks Intown in Albany, GA

Hines, a 56-unit family community; Thronateeska Homes, a 32-unit family community; and Golden Age Apartments, a 66-unit senior living community. The studio, one-, two-, three-, and four-bedroom apartments have undergone full interior modernization, including new HVAC systems, renovated kitchens with dishwasher and electric range, modern bathrooms, vinyl flooring, updated PENNROSE



fixtures, and in-unit washer and dryer. Residents will also have access to robust on-site amenities, including a community room, playground, on-site management, 24/7 emergency maintenance, and professionally landscaped grounds.

"History has been made with the rehabilitation of Phase 1 of our multi-phase renovation project. Our job is to provide the vulnerable residents of Albany with a safe and supportive platform from which to stabilize their families and move forward with their lives. We want to see Albany continue to grow and thrive, so we have to keep working to create housing that can appeal to working families of a variety of income levels," said Dr. William Myles, CEO of Albany Housing Authority.

Permanent financing for the project includes Hunt Capital Partners equity through the DCA 4% Low Income Housing Tax Credit program, a Freddie TEL Ioan through Truist Bank, a DCA HOME Ioan and Albany Housing Authority funding. Construction funding also includes a construction Loan through Bank OZK along with Tax Exempt Bonds.

"This milestone was accomplished through a collaborative effort and will provide much-needed quality affordable housing options for hundreds of residents," said Jeff Weiss, President of Hunt Capital Partners, which provided the federal and state equity for the project.
